OFFICIAL SWEEPSTAKES RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. TIMING: Bay City Bridge Partner's ("Sponsor") Thanksgiving Game Tickets Sweepstakes ("Sweepstakes") eligibility is open until November 17, 2024, at 11:59:00 p.m. Eastern Standard Time. ("Sweepstakes Period").

2. HOW TO ENTER: There are two (2) ways to enter: 1) **Existing** BC-PASS account holders with an active BC-PASS account during the official Sweepstakes Period will automatically receive one entry. 2) **New** customers can create a BC-PASS account by phone, call (855)648-4330, online at <u>www.bc-pass.com</u>, or in person BCBP Walk-In Center located at 300 Center Avenue, Suite 101 Bay City, MI 48708 before the Sweepstakes Period ends. <u>Limit one entry per account</u> regardless of the number of transponders on the account.

3. ELIGIBILITY: Open to legal residents of the forty-eight (48) contiguous United States and D.C., who are 18 years of age or older with a valid U.S. driver's license at the time of entry and subject to the exclusions listed in paragraph 3A. BC-PASS account must be deemed in good-standing to be eligible for the Grand Prize.

3A.
